

Why Building Permits Matter

WHY DO I NEED A PERMIT?

Short Answer: A permit is required whenever you construct, enlarge, alter, repair, move, demolish, or change the occupancy of a building or structure – and for most installations of electrical, plumbing, mechanical, and impact-resistant coverings. This is required by the Florida Building Code (Section 105) and Florida statutes governing building permits.

WHAT PERMITS PROTECT

- **Your safety-** permits ensure work meets the minimum structural, fire-safety, and life-safety standards in the Florida Building Code.
- **Your investment-** inspected, permitted work preserves property value and insurance coverage. (Insurance companies commonly require compliance with local code.)
- **Your neighbors & emergency responders-** correct permitting helps protect adjacent properties and ensures firefighters and EMS can safely access and respond.

WHEN A PERMIT IS REQUIRED

You need a building permit to:

- Build a new structure or add to an existing one.
- Change the use/occupancy of a space.
- Substantially alter, repair, move, or demolish a structure.
- Install, replace, or enlarge electrical, plumbing, mechanical, gas systems, or impact-resistant coverings.
- Any roof repairs or replacements are highly recommended regardless of cost for insurance purposes.

OWNER-BUILD? IMPORTANT LEGAL NOTES

If you act as your own contractor (owner-builder), you may still obtain an owner-builder permit - but you accept the responsibilities and liabilities for code compliance, inspections, and worker insurance/compensation issues. Hiring a licensed contractor transfers some responsibility; verify licenses before hiring. See Florida statutes on owner-builder and contractor responsibilities.

WHAT HAPPENS IF I DON'T GET A PERMIT

- You may be required to **remove or retrofit** the unpermitted work at your cost.
- You may face stop-work orders, fines, or civil enforcement by the local enforcing agency.
- Unpermitted work can make it difficult to sell the property, obtain insurance claims, or document code compliance.

(Florida law sets application, review, and enforcement rules for permits; local agencies must follow statutory timelines and processes.)

HOW TO GET A PERMIT (QUICK STEPS)

1. Confirm what permit(s) you need - building, electrical, plumbing, mechanical, roofing, etc.
2. Submit a completed permit application with plans/specifications to your local building department.
3. Schedule required inspections as work proceeds.
4. Obtain final approval/Certificate of Completion or Occupancy.
